TEAM JAPAN (Candidate) Personal Data Submission Consent Form for the multi sports international competitions

The Japanese Olympic Committee ("JOC") requests the submission of personal data as set out below.

The submitted personal information (including latest personal information when updated. The same applies hereinafter). The submitted personal information (including updated personal information when updated) and the individual's photograph (hereinafter collectively referred to as 'personal information etc.') shall be stored in the JOC's database system and handled in accordance with the following provisions. In addition, the information may be used for the purpose of contributing to the improvement of Japan's sports performance and the development of sports medicine and science, etc., after being processed and converted into statistical information and anonymized record.

1. Personal information to be collected

- ① Profile Information
Names (passport name, registered name), name for competition, gender, date of birth, age, affiliation, background, etc.
- ② Contact Information
Email address, residence address, telephone numbers, etc.
- ③ Information required for Sport event registration
Passport details etc.
- ④ Medical information relating to health conditions.
 - (a) Medical check and orthopaedic medical certificates (including a copy of the ECG)
 - (b) NOBORI app-based medical questionnaire
- ⑤ Other items of personal information obtained as necessary.

2. Purpose of use

- Procedures for participation in the multi sports international competitions
- Storing information in database systems
- Communication of necessary information (limited to (②) of 1. Personal information to be collected to be collected).
- Provision of information to the media (limited to (①) in 1. Personal information to be collected)
- Medical care and support at the multi sports international competitions (limited to (④) in 1. Personal information to be collected)
- Use for JOC publication and productions (limited to (①) in 1. Personal information to be collected)
- Other uses for the Olympic Movement promotion (limited to (①) in 1. Personal information to be collected)

3. Provision to third parties

- Personal data and other information obtained may be provided to third parties in the following cases, in addition to cases where it is required by law
 - ① When the information in "1. Personal information to be collected" above is provided to the organisers of the event organisers, etc. for the purpose of participation in the multi sports international competitions
 - ② Where the information in (①) of "1. Personal information to be collected" above is provided to the media for the purpose of providing information to the press and broadcasters.
 - ③ When the information in (④) of "1. Personal information to be collected" above is provided to the medical officer of the sport events at the request of the sport federation to which the person belongs, for the purpose of medical services and support at the

multi sports international competitions

4. Miscellaneous.

- The JOC can request disclosure (notification of purpose of use, disclosure, correction, addition or deletion of content, cessation of use, erasure and cessation of provision to third parties) of personal information and other information held by the JOC.
- If you wish to request disclosure of your personal information, etc., please contact the following person(s). When requesting the disclosure, etc., the identity of the person making the request will be confirmed in order to prevent the leakage of personal information to persons other than the person concerned and the rewriting of personal information by persons other than the person concerned. Only when the identity has been confirmed the personal information shall be disclosed.
